Proposed Mr Taylor, Seconded Mr Borrie, that alternative plan of subdivision be sent to Mills & Co to consider as an alternative scheme. Council also to have one and notify Council of plan having been sent to vendors and also ask Council to request Government to take steps to make resumption possible if other steps fail. Carried

Proposed Mr Griffin, Seconded Mr Borrie, that Council be asked to top dress The Parapet to save future expense, also ask Council when extension of Edinburgh Road will be proceeded with. Carried
